## URGENT FRAUD ALERT: PROTECT YOUR ONLINE BANKING INFORMATION



Your security is our top priority and we are aware that criminals are actively spoofing the credit union's phone number (for both phone calls and texts) and our email addresses. We are reaching out to remind you of an important safety rule regarding your GENCO Federal Credit Union account.

### GENCO EMPLOYEES WILL NEVER...

*ask for your online/home banking username or password via phone call, text or email.*



### GENCO EMPLOYEES WILL NEVER...

*ask you to provide one-time passcodes or text verification codes over the phone, by email, or by text message.*

If anyone contacts you claiming to be from GENCO Federal Credit Union and asks for this information, **do not provide it**. This includes situations where the caller ID, phone number, or email address appears to be from GENCO. Criminals can use technology to spoof phone numbers and email addresses to make them appear to be from GENCO.

### PLEASE REMEMBER:

- ▶ Never share your online or home banking credentials with anyone
- ▶ Never provide one-time passcodes or verification codes to anyone
- ▶ GENCO will not request this information under any circumstances

If you believe you may have shared sensitive information or received a suspicious call, text or email, please contact us immediately using the phone number listed on our official website or the back of your debit/credit card.
